LOCATION

The property is prominently located on Camberwell Church Street in the heart of Camberwell, a vibrant and increasingly affluent South East London suburb. The immediate area is home to numerous successful independent operators operators including Daily Goods, Theo's, Silk Road and FM Mangal. Other points of interest include The Camberwell College of Arts, Goldmsiths University. The South London Gallery and Kings College and Maudsley hospitals.

The area is well served with bus services as well as rail / tube services from Denmark Hill (0.6 miles), Oval station (1.1 miles) and Peckham (1.2 miles)

DESCRIPTION

The 1100 sq ft ground floor unit was completely refitted from shell condition 12 months ago and boasts a simple yet atmospheric design with seating for approximately 40 covers. A long counter bar with bar seating forms the heart of the ground floor. There is also a downstairs tasting room for 12-15 people as well as ancillary storage and a small external space at the rear used for barbequing and seating.
