LOCATION

Prominently located in the heart of Woking at the corner of Commercial Way and Church Path. The property forms part of Albion House (now known as Woking One) which has just benefited from a £7m redevelopment to include a new façade, public piazza and 36,000 sq ft of Grade A office space. Nearby operators include **Carluccio's, Tante Marie (Gordon Ramsay cooking school), Bills, Las Iguanas, Patisserie Valerie** and **Cote**. <u>https://wokingone.co.uk</u> Woking Train Station is 1 minute walk from the property offers 14 trains per hour to London Waterloo taking 27 minutes.

Works are also underway on the Victoria Square development on Commercial Way due for completion in 2020 and which will include a 189 bed Hilton Hotel, 429 flats, a multi-storey car park, two new public piazzas and a 50,000 sq ft Marks & Spencer.




